Before you can vote in Iowa, you must be registered. To register to vote in Iowa, you must:

1. be a citizen of the United States
2. be a resident of Iowa
3. be at least 17 - 1/2 years old (you must be 18 to vote)
4. not have been convicted of a felony (unless your rights have been restored)
5. not currently be judged "mentally incompetent" by a court
6. give up your right to vote in any other place

If you do not meet all these qualifications, you should not register to vote.

1. Office of the County Auditor: in person, by mail, or website www.storycounty.com
2. Office of the Iowa Secretary of State: in person, by mail, or website (www.sos.state.ia.us)
3. Most telephone books

You should receive a receipt of this application within 14 days. If you do not, contact the county auditor (382-7210).

Absentee Ballot
