## ANNUAL MEETING ITEMS

**General Meeting Planners' Report**

"General Meeting Planner" is a new term for the Ames League. Until this year, the monthly general meetings were planned by the Vice President(s) or President(s)-elect. At the 2006 Annual Meeting, the responsibilities were transferred to this position.

Several meetings this year were devoted to topics of interest at the national or state level. The September meeting was on Predatory Lending; the February meeting was devoted to the current LWVIA study on Sentencing and Corrections; and the March meeting was on background material for the LWVUS study on immigration.

The October meeting was an opportunity for members to meet and hear from the visitors from the Ukraine who participated in the "Accountable Governance" program offered by the Ames League.

In November, we brainstormed on possible state and local studies, and made suggestions for meeting programs for the 2007-2008 year,

The January meeting was devoted to LWVIA Legislative Priorities, to help us prepare for advocating League positions with our legislators.

The April Annual Meeting will follow brunch at Green Hills.

We look forward to the May meeting, when we have our Annual Salad supper and review the recent legislative session.

We thank fellow members--Sharon Wirth, Jan Beran, Lauris Olson, Johnnie Hammond, Mary Richards, and Judie Hoffman—for presentations. We also thank Selva Lehman, Nancy Brown and the Ukrainian visitors for presenting the October program.

We felt privileged to be able to schedule all the evening meetings at Northminster Presbyterian Church. We appreciate their spacious, comfortable room, ample parking and well-furnished kitchen.

**Proposed LWV Bylaws Change 2007**

The first three articles of all local and state League bylaws must be consistent with those of the LWVUS in order to define and maintain the unity of the organization and the powers and privileges of members. The statement of the purpose for the League was amended at national convention in Minneapolis in 2006. Consequently the LWV of Ames must amend its statement of purpose to be consistent with LWVUS Bylaws.

**MOTION:** Recommend amendment of Article II, Section 1. Purpose. The purpose of the League of Women Voters of Ames, a nonpartisan political organization, encourages informed and active participation in government, works to increase understanding of major public policy issues, and influences public policy through education and advocacy.

(The current version reads, "The purpose of the League of Women Voters of Ames shall be to promote political responsibility through informed and active participation of citizens in government.")

**Program Planning for 2007-08**

A program planning meeting was held on Nov. 16, 2006. In regard to state study issues, Mary Richards and Johnnie Hammond presented an update on the state study committee dealing with prison issues. Local study ideas discussed were focused on updating the affordable housing position and updating/expanding the leisure and recreation position. The issue of timing in regard to study vs. advocacy was discussed. After review of our existing positions on these issues and because of current community discussions and pending actions on these issues, the Board chose not to recommend a new local study.

After giving much consideration to proposing a state study on mental health issues, the Board chose not to pursue this. Rationale behind this was two-fold: (1) lack of willing leadership from within the LWV of Ames and (2) interest in focusing our time and resources on the national study topic of immigration.

**In regard to programming for 2007-08 the Board recommends:**

1. Participation in the LWV US Immigration Study.
2. Retention of current Positions on local issues specifically:
  - County Recreation**
  - Land Use, including Natural Resources and Development**
  - Electric Utility**
  - Leisure and Recreation**
  - Affordable Housing**
  - Children at Risk of Abuse from their Caregivers**
  - Story County Hospital** and
  - Transportation Needs in Story County.**
 (See program book for specific details.)
1. A proposed word change in our Living Wages position, that the word "wages" be changed to "income" in the first paragraph.

With the change the **Living Wages** position would read:

The League of Women Voters of Ames:

- Supports adequate income to enable working people to cover basic needs and to live with dignity and a sense of self-worth.
- Affirms the principle of equal pay for equal work.
- Supports the City of Ames and Story County adopting a Living Wage ordinance requiring a livable wage be paid:
  - o to all full- and part-time city and county employees,
  - o by firms whose contracts exceed \$15,000 for any 12-month period. (This applies to the hours the employees are working on city or county contracts.)
  - o by firms that receive economic development money or incentives from the city or county.

## **First Call to LWVIA Convention 2007**

**The League of Women Voters of Iowa will hold its 2007 Convention on June 2, 2007 at the Holiday Inn in Cedar Falls, Iowa.**

**Workshops, a business session and a speech by Chief Justice of the Iowa Supreme Court Marsha Ternus will be part of the convention agenda.**

**Article VIII, Section 2** of the LWVIA Bylaws says, the convention shall consist of the following delegates:

- members chosen by local Leagues;
- members chosen by member-at-large units;
- members-at-large;
- past state presidents affiliated with the LWVIA, and;
- members of the board of directors of the LWVIA

**Article VIII, Section 5** of the LWVIA Bylaws says, the convention shall consider and authorize a program for action, shall elect officers, shall adopt a budget for the ensuing year, and shall transact such other business as may be presented.
