VOTER INFORMATION

Before you can vote in Iowa, you must be registered. To
register to vote in Iowa, you must:

- be a citizen of the United States
- be a resident of Iowa
- be at least 17½ years old (18 by election day)
- not have been convicted of a felony (unless your rights have been restored)
- not currently be judged "mentally incompetent" by a court
- give up your right to vote in any other place
- **NEW REQUIREMENT:** Must possess an Iowa driver's license, and Iowa non-operator ID card, or and Iowa Voter ID Card
